Minutes of the Meeting of Wisbech St Mary Parish Council held on Monday 11th December 2017 at 7pm at Thorney Toll Village Hall.

OPEN FORUM

Ms S Jackson from Swann Edwards Architecture Ltd referred to planning applications 0223,1097, 1098, 1115, and 1125, pointed out the benefits and asked councillors to support them. Ms S Pitcher referred to planning application 1115/F. She was accompanied by Mr R Kenworthy. Both live at High Road, Guyhirn. Ms Pitcher stated that she was representing seven other people who could not attend the meeting. Ms Pitcher stated that they opposed the application as it would mean more people, more traffic on a narrow unlit road and consequently exacerbate an already unsafe situation. Mr Kenworthy added that due to flood risk considerations footings were planned to be 0.5m above the road level such that the new properties would overlook the existing. He considered that the flooding argument made no sense as if existing properties were flooded the proposed ones would be standing in a lake. Ms Pitcher considered that if flooding were a genuine concern new housing development should not be permitted.

6. CORRESPONDENCE RECEIVED

- The Clerk read an email from Cllr S Tierney dated 20 November 2017. It was agreed to invite Cllr Tierney to the February or March meetings.
 - (b) Cllr S King FDC Street Lighting Update
- The Clerk read a letter from Cllr S King dated 21 November 2017. FDC planned to have new arrangements in place for April 2018. In the interim faults should continue to be reported to assets&projects@fenland.gov.uk or 01354 654321.
- The Clerk supplied Cllr King with details of lighting units awaiting repair; FPC5 Front Road Murrow, FPC11 High road Guyhirn, FPC1 Fen Road Guyhirn. Cllr Fish reported that column at Lindens Close knocked down recently by the FDC Refuse Vehicle had been made safe.

7. HIGHWAYS MATTERS

(a) Jointly Funded Minor Highway Improvements 2018/19

The Clerk reported that the bids had been submitted, details and estimates were awaited from CCC.

8. BUDGET FOR 2018/19 PRECEPT

(a) FDC Letter 6 November 2017

The Clerk read a letter from FDC explaining that the Council Tax Support Grant for 2018/19 would be the final year of payment and that Concurrent Functions Grant would be considered by Cabinet 14 December 2017. FDC recommended that the final precept for 2018/19 be set at the January meeting. **Noted**

(b) Draft Budget 2018/19

The Clerk referred to the Budget Review (9b below) and explained the figures which gave a Draft Budget for 2018/19 of £86,953. If these figures were agreed the precept could be maintained at £53,732. The final budget would be agreed at the meeting 15 January 2018. **Noted**

9. FINANCE MATTERS

(a) To receive the Budgetary Control Report(BCR) for 2017/18 to date

The Clerk reported that a BCR could not be provided as the statement from Barclays had not been received in time. He added that the insurance claim for the vandalised bus shelter base had been received and a £4000 section 106 contribution to a bus shelter had been received from FDC. **Noted**

(b) Budget Review to 11 December 2017

The Clerk circulated a Budget Review including an estimate of expenditure to year end and revised budget for the year. The estimated balance at year end was £84,966 which should be regarded as a healthy position considering the precept and commitments. The Review included predicted income for 2018/19 of £62,054 taking into account the reduction in Council Tax Support Grant and assuming the precept was maintained at £53,732. **Noted**

10. PARISH PROPERTY

(a) Maintenance

The Clerk reported that the majority of maintenance for the year had been completed. Only minor expenditure was anticipated before year end. **Noted**

(b) Bus Shelters

The Clerk reported that three litter bins had been installed, the litter bin at Thorney Toll was yet to be moved. **Noted**

(c) Defibrillators

The Clerk reported that all Parish Council defibrillators were operational and registered. He had supplied the Cambridgeshire Community Foundation with the final project monitoring data. The unit at the Wisbech St Mary Community Centre was not yet registered. Cllr Wheeler agreed to liaise with the Community First Responder to ensure the unit was registered. Cllr Wheeler confirmed that a demonstration of how they worked was planned for the new year.

(d) Planters

Following discussion it was agreed to continue to encourage those who had committed to maintaining the planters, the planter outside Wisbech St Mary Church would be replanted by S Bowles. **Agreed** Cllr Wheeler asked the Clerk to compile a list of planters. The Clerk was asked to invoice sponsors in the new year.

11. HIGH ROAD WISBECH ST MARY - SURFACE WATER DRAINAGE

Cllr Booth confirmed that at a meeting arranged by the North Level Internal Drainage Board residents had agreed to contribute to the cost. Work would commence as soon as possible in the New Year. When the cost is known the Council may need to review the financial contribution agreed.

12. REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr King reported that the FDC Budget process was underway and the Fenland Transport Strategy meetings would commence Thursday, he urged councillors to attend. Cllr Booth reported that FDC would meet Thursday and that Overview and Scrutiny Committee would be reviewing Roddons performance in dealing with heating problems.

- 1. Cllr Davies reported that the steps at the river bank opposite Chapelfield Road were very slippery and a person has fallen.
- 2. Cllr Knight stressed the need to address the problem of vehicle speeds and parking near the shops at Wisbech St Mary. It was noted that physical measures would be needed before a speed limit reduction would be approved through the Local Highway Improvement process.
- 3. Cllr Mann reported a nameplate 'Plash Drove' at Murrow Bank pushed over.
- 4. Cllr Fish reported that the trees on the approach to Thorney Toll lay-by had not been pruned and understood that Clarion had taken over from Roddons.
