Applicant Mr L Smith. Agent Mr Barry Nichols. Following discussion, it was considered that there was sufficient provision already in the area and the access was inadequate. Refusal was proposed by Cllr Davies seconded by Cllr Fish and passed by seven votes.

8. HIGHWAYS MATTERS

(a) Highways

Cllr Humphrey reported that new lines had appeared at Bellamys Bridge but reiterated his comments of last meeting that some form of speed reducing feature should be installed. The Clerk confirmed that his comments had been passed on to CCC but as yet a response had not been received.

Cllr Knight reported that CCC had taken no action regarding the two gullies at High Road Wisbech St Mary and he proposed to escalate the issue.

Cllr Davies reported that the land owner had cut back the vegetation at Gull Road. There is mud/debris on the verge that needs to be cleared by machine to return the usable width of carriageway to its former width. The Clerk was asked to explore who this should be escalated to.

(b) Street Lighting

Cllr Davies raised the issue of the FPC11 High Road Guyhirn for which Balfour Beatty had estimated £1068 to renew which seemed excessive reported that the unit was working. The Clerk reported that he had not received a reply from FDC. He was asked to press for a response.

(c) Street Pride.

Cllr Knight detailed proposals for planters at twelve locations and suggested that our contractor could construct and place with volunteers planting plants donated by local suppliers. Maintenance was yet to be determined. In view of the lack of response from CCC to enquiries the Clerk was asked to notify CCC of proposals for planters signs and a seat to the effect; 'unless we hear from you by the end of April we shall assume that you have no objection'. Cllrs Knight and Humphrey agreed to progress the proposals. It was proposed to trial planters at Wisbech St Mary or Tholomas Drove (Parish Council land) to gauge the public's reaction. **Agreed**

The Clerk was asked to write to Mr P Canham requesting that he remove agricultural machinery from the land at Tholomas Drove which had badly churned up parts of the green.

The Clerk read an offer from Mr B Sandall of a wooden seat for High Road/Church Road Wisbech St Mary. The offer was well received and would be built into proposals if possible.

9. FINANCE MATTERS

(a) To receive the final budgetary control report for 2015/16.

The Clerk drew attention to the total income of £68,447.68 and to the £530 interest achieved on the £100,000 deposit account and to the total spend of £47,146.88. The Bank Reconciliation balanced at year end. Cllr Knight commented that taking into account commitments e.g. street lighting, bus shelters etc. we would have a balance of over £40,000 which was a good position. **Noted**

- (c) Corporate Governance Questionnaire (CGQ) for certification by the Chairman. The CGQ was introduced by the Chairman who made reference to items discussed during the year. Approval was proposed by Cllr Knight and seconded by Cllr Davies, agreed unanimously and signed by the Chairman. **Agreed**
