# 2. TO SIGN AND APPROVE MINUTES OF MEETINGS dated 1<sup>st</sup> August 2016

The minutes were taken as read, agreed as a true record and signed by the Chairman.

## 3. MATTERS ARISING FROM PREVIOUS MINUTES (information only)

(a) Allotments Thorney Toll rear of properties 3 – 16 Wisbech Road

The Clerk read a response received from Dawn Sadler, Senior Environmental Health Officer for Fenland District Council which included a response from Circle Housing Roddons. The matter is with a barrister with a view to resolving the issue.

(b) A47 Guyhirn, no right turn

The Clerk read a response received from PCSO Sue Clarke. It is unlikely that the Police can take action unless there is evidence and corroborating evidence. It is therefore regarded as a highways issue. Consequently, the Clerk requested the PCSO to complete a Traffic Management Form.

The Clerk read a response received from Highways England to the effect that a number of highway improvements were planned along the Guyhirn junction. These are at the feasibility stage; more information should be available spring 2017.

(c) Abandoned vehicle

The Clerk read a response received from PCSO Sue Clarke; when alerted to an abandoned vehicle the Police complete the necessary checks, a Police Aware sticker is placed on the vehicle and FDC notified. Such vehicles can be removed immediately if it is considered to be in the public interest to do so.

Cllr Knight advised that he had received additional information regarding the proposed access arrangements and suggested that Councils previous decision should be reconsidered. Following discussion it was proposed by Cllr Knight, seconded by Cllr Allen that the objection to the access should be removed providing that CCC highways consider it satisfactory. The motion was carried by five votes to nil.

## 6. CORRESPONDENCE RECEIVED

- (a) Thorney Toll Village Hall thank you for the grant Noted
- (b) Cambridgeshire ACRE Guyhirn Village hall. As the Village Hall is not Parish Council property the documents were handed to Cllr Allen who offered to pass them on to the Parish Hall Committee. Cllr Allen explained that there was a possibility that the Hall could be sold. The Deeds required that a public meeting take place, which had been arranged. If people vote to retain the Hall they must form a management committee. He encouraged as many people to attend as possible.

## 7. HIGHWAYS MATTERS

## (a) Street Lighting

The Chairman invited Cllr Booth to feedback from the meeting of Parish Councils with Cllr King, FDC Portfolio Holder for Rural Affairs on 31 August 2016. Cllr Booth explained that FDC had obtained three quotations; Balfour Beatty offered the lowest, the next 60% higher and the next 140% higher. All Parish Councils were unhappy to accept the lowest as they were had great concerns regarding the quality of service offered. It is understood that the value of maintenance per annum is £40,000. Cllr King had explained that due to the need for economy it was likely that Balfour Beatty would be appointed as preferred supplier to commence from April 2017 for three years.

Cllr Booth said that Cllrs Hufton and Connor had undertaken to explore costs of resurvey of all Parish Council CAT 2 lights together with the cost of repair and maintenance of Parish Council lights with the other two suppliers, Electrical Testing and SKANSKA.

The Clerk confirmed that details of the Wisbech St Mary Parish Councils street lights had been supplied to Cllr Hufton: Good 52, Fair 84, Poor 13 and Bad 0, total 149.

FPC11 High Road Guyhirn – The Clerk stated that the quotation requested had still not been supplied and that the matter had now been escalated to the Head of Service.

(b) Street Pride

Cllr Knight reported that a pilot litter-pick had been arranged for Saturday 17 September from 10am to noon. Rebecca Robinett, FDC, will attend. It had been publicised in Village Voices. He proposed to offer some refreshments up to a value of £75. Agreed

(c) Community Highway Volunteering Scheme

The Clerk read extracts from a document received from CCC Highways. Cllr Knight suggested that it would be unwise and counterproductive to have two initiatives running at the same time and that Street Pride should be encouraged. Agreed

## 8. FINANCE MATTERS

(a) To receive a report on the External Audit 2015/16

The Clerk referred to the Report; there were no matters giving cause for concern and no matters to be drawn to the attention of Council. The Chairman thanked the Clerk for his efforts. Noted

(b) To receive a budgetary control report for 2016/17 to date

The Clerk circulated the report and drew attention to Treasury Deposit interest received, Bank Reconciliation balances and the Wash Pit Fund balance which he proposed would remain at the figure shown with interest expended on capital projects for the benefit of parishioners. **Noted** 

(c) Council Tax Support Grant - FDC letter regarding phasing out

The Clerk referred to the letter from FDC stating that the Grant would be £3,799 in 2017/18 and £1,899 in 2018/19 and zero 2019/20. Noted

Cllr Davies asked the Clerk to raise this issue during budget discussions.

(d) Insurance Premium Tax – increase to 10% from 9.5% Noted

## 9. PARISH PROPERTY

(a) Maintenance – seat Chapel Avenue Wisbech St Mary

Following discussion, it was proposed to replace the seat with a Glasdon Phoenix seat in recycled material. Cllr Knight will remove the plaque and have it refurbished. The Clerk was asked to obtain quotes for the disposal of the existing seat, new concrete base, receive and fix new seat.

(b) Tholomas Drove grassed areas - update

Following discussion, it was agreed to take no further action.

(c) Bus Shelters

Cllr Broker had met with CCC officials. They have asked for wider footways, which will place the shelters closer to dykes, and to raised kerbs and footways to suit low floor busses which are not essential to the bus companies. Councillors considered that the extra engineering works would make the cost prohibitive. It was agreed to proceed with the standard design (not the raised kerbs).

(d) Defibrillators

Following discussion, it was agreed that Cllr Britain would progress the one at Guyhirn and Cllr Knight the one at Wisbech St Mary. It was noted that there was one indoors at the Wisbech St Mary Primary School.

Cllr G Booth reported:

# 12. ANY OTHER BUSINESS (for information only)

Cllr Knight reported that the school had been very appreciative of the Councils interest and of the additional commemorative medals supplied.

The Chairman raised the drainage issue at High Road, Guyhirn. The problem was highway gullies not working successfully, drainage pipes broken, sections of dykes filled in hence flooding following prolonged rainfall. The Chairman will raise the issue with the North Level Internal Drainage Board. The Clerk was asked to add this item to the next Agenda.

Cllr Wheeler said that lorries leaving Delamore were travelling through Wisbech St Mary when they had an alternative route that would avoid the village.

Many vehicles had been parked in the centre of Wisbech St Mary village causing an obstruction over a long distance.

Cllr Davies reported the appalling smell over several days coming from fields near Mouth Lane believed to be as a result of AW 'cake' waste spread on the fields. The Clerk was asked to enquire if this was permissible and what the regulations were governing such actions.

The Chairman raised the issue of the fence at Gull Road – he was awaiting a form to be returned by the FDC Enforcement Officer.

The Chairman complimented the school on their facilities and asked the Clerk to thank the Head teacher for her hospitality.
