Minutes of the Annual Meeting of Wisbech St Mary Parish Council held on Monday 18th May 2015 in Wisbech St Mary Community Centre.

1. APOLOGIES FOR ABSENCE.

2. ELECTION OF CHAIRMAN AND VICE CHAIRMAN.

Chairman: Cllr Britain was proposed by Cllr Broker, seconded by Cllr Davies and agreed unanimously.

Vice Chairman: Cllr Knight was proposed by Cllr Broker, seconded by Cllr Allen and agreed unanimously.

Brian Payne said how much he had enjoyed his time as a Parish Councillor working with all councillors both past and present, and thanked them for their support. He wished all well for the future. Brian urged councillors to view other Parish Council web sites to view their minutes to see how others worked, clearly there is work to be done. Brian expressed his gratitude to Geoff Wilkinson who had stepped into a 'mine field' at a difficult time and had handled things well. Brian offered his assistance in the future if that would be helpful.

Cllr Britain thanked Brian on behalf of all councillors for what he had done on behalf of the Parish. Brian then presented Cllr Britain with the Chairman's badge of office.

All councillors were circulated with Declaration of Acceptance Office, Code of Conduct and Register of Members Interests. Chairman, Vice Chairman and all councillors completed Declarations of Office and handed them to the Clerk and retained the Code of Conduct. All councillors retained the Register of Member Interests for completion to be returned to the Clerk who would retain copies and forward to Fenland District Council (FDC).

The Chairman thanked Peter Barnes for his 47 years service to the community at both Parish and District Councils. Peter responded that he had recently attended a garden party at Buckingham Palace which had been a very good day, and thanked everyone very much.

The minutes were taken as read, agreed as a true record and signed by the Chairman.

4. MATTERS ARISING FROM PREVIOUS MINUTES (information only)

Cllr Davies asked if a letter could be supplied to the Club confirming the Councils support for their plans and that the lease would be extended to suit their requirements. The Clerk confirmed that a legal agreement was in place until 2022 and that a new agreement would be necessary when plans had progressed to the stage when a new term could be agreed.

- (a) Cambridgeshire County Council (CCC) Cants Drove. CCC had met with Bio Cow and permitted them to construct passing bays on their land along Cants Drove between Gull Bank and Long Drove in an effort to alleviate some of the traffic issues. **Noted**

8. HIGHWAYS MATTERS

Highways and street lighting matters.

(a) Bellamy Bridge. No further update.

Highways and streetlight reports from Councillors on problems causing immediate concerns.

(b) Highways

Cllr Knight raised the issue of two blocked gullies at Wisbech St Mary.

Cllr Knight described the area of highway verge where bollards had been removed and a vehicle parked damaging the verge. CCC had been made aware.

Cllr Broker drew attention to indiscriminate parking outside Murrow School. Cllr Booth said that PCSO Sue Clarke was covering that area. Cllr Bligh added that she had raised the issue with Sgt Boughen who had advised her to email details of 'hot spots' direct to the police.

Cllr Broker also highlighted the deep ruts forming on Murrow Bank which the Councillors had previously raised with CCC Highways and the slit road off the A47 breaking up. The Clerk read a responds received from CCC Highways to his report following the issue raised by Cllr Allen at the last meeting – 'I have submitted a scheme for this junction to be patched. I don't at present, know if it has been successful or not'.

Cllr Davies raised the lack of action to matters raised previously and felt we should continue to press for action.

Cllr Broker commenting on the conifers planted in the highway verge at Murrow Bank suggested that the FDC enforcement officer should be contacted and asked to take action as they had clearly been planted by those responsible for the development and were therefore acting outside of the approved boundary lines. Clerk to progress.

Cllr Davies drew attention to the litter bin that had been removed from the area containing the bottle banks at Guyhirn.

The Chairman again drew attention to damaged sumps as a result of deep ruts along Gull Drove.

(d) Streetlights.

Cllr Booth said that he had received an enquiry regarding the street light outside Murrow Village Hall that had been removed following a road traffic collision. The Clerk confirmed that an order for the replacement was with Assets and Projects at FDC but that no response had been received, reminders had been sent.

9. FINANCE MATTERS

(a) To receive the budgetary control report for 2015/16 to date. The Clerk drew attention to the receipt of VAT paid during 2014/15 and that unclaimed from 2013/14 from HMSO and that the bank reconciliation balanced.

The 2015/16 balance recorded was £171,831.71. Noted

(b) Approval of Accounts and Annual Return for the year ended 31 March 2014/15. The Clerk drew attention to the Annual Return and read Section 2 – The Annual Governance Statement. He went on to highlight amendments require to the figures following Internal Audit. **Approved** The Chairman and Clerk then signed the Annual Return.

Cllr Knight had explored design options and described a design he thought worth progressing which will be circulated for discussion at the next meeting.

At the Chairmans invitation Brian Payne suggested one be installed at Murrow.

11. REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr Both explained the reasons for the low response to telephone enquiries at FDC's contact centre. 68% had been achieved against their target of 70%.

Cllrs Booth and Bligh had received representations that the 40mph speed limit should be reduced to 30mph at High Road Wisbech St Mary and Gull Road, Guyhirn.

Cllr Bligh raised the possibility of introducing the 'baby weighing' process.

- (a) Guyhirn Village Hall have requested a seat to go outside the Village Hall. Following debate it was agreed that they should make a formal request.
- (b) Cllr Reay asked if one of the old notice boards could go at the village pond as an information board. It was agreed to add this as an agenda item for the next meeting.
- (c) Cllr Knight asked how Street Pride could be extended. Cllr Booth replied that £500 grants were available to encourage new groups. It was agreed to add this as an agenda item for the next meeting.
- (d) D Broker had been made aware that there was an experienced medic who could operate and manage the defibrillator. It was agreed to add this as an agenda item for the next meeting.
