Cllr King said he was exploring the planning issues; number of vehicle movements generated, passing places and the expansion of the business. Cllr Davies suggested the planning enforcement officer should check that the business operation was as approved and complied with any planning conditions.

(a) Street Lighting - FDC letter 24 April 2018

The Clerk referred to a letter received from FDC to the effect that the street lighting tender process was running four weeks behind schedule such that proposals were now expected week commencing 28 May 2018.

(b) Local Highway Improvement Initiative 2018/19 Bellamys Bridge

The Clerk read an email from CCC regarding proposals some of which may require additional funding from the Parish Council. An amended design was expected within the next two weeks. Cllr King added that the Fenland Transport Plan was an opportunity to bid for a more substantial improvement.

The Clerk circulated copies to all. Council reviewed each of the Statements. Following review it was proposed by Cllr Davies seconded by Cllr Humphrey that the Annual Governance Statement be approved. The resolution to accept the Annual Governance Statement was **Approved unanimously**. The Clerk and Chairman signed the Statement.
