Cllr Patrick had attended the FDC Planning Committee. Committee voted against the application but following a further vote Committee voted in favour. Consequently, FDC Cllr Booth has complained regarding the way the process was managed.

It was believed that there is a Parish Council bus shelter within the visibility splay of the new estate road access – Councillors agreed that permission to move the bus shelter should be rescinded.

Cllr Wheeler reported that those carrying out the Peer Review were of the opinion that if FDC had gone against Parish Council recommendations FDC Planning should write and explain why. The Peer Review Report should be sent to the Parish Council.

7. HIGHWAYS MATTERS

(a) Street Lighting

The Clerk reported a new street lighting column had been installed outside 4 Fen Road Guyhirn.

The Clerk referred to a letter received from FDC dated 23 July 2018 which confirmed FDC support for lighting energy costs for 12 months from 1 August 2018 and that the Parish Council would need to make its own arrangements for energy costs. FDC would pay a grant until 1 August 2019 of either the estimated cost or the actual cost whichever is he lesser amount. It was noted that there would be further representations made to FDC regarding energy costs. **Noted**

(b) Local Highway Improvement (LHI) Initiative 2019/20

The Clerk reported that bids had been made to CCC and Wryde Croft Wind Farm.

Further details were awaited from CCC for the Bellamy Bridge 2018/19 scheme. The High Road 2018/19 scheme required further design followed by public consultation for the change in speed limit. The Bellamy Bridge and High Road schemes to be delivered concurrently in early 2019. **Noted**

Cllr King reported

(a) Tholomas Drove tree pruning should start today

- (b) Sandbank an order has been raised to repair the subsidence
- (c) There are six vacancies in the Local Highway Improvement Team recruitment is underway
- (d) There are six vacancies out of twenty-one positions in the Highway Maintenance Teams (one out of five in Fenland) this is a national problem

Cllr Britain noted that Gull Drove is to be temporarily closed.

Cllr Wheeler reported potholes in Bevis Lane and Rummers Lane

Cllr Fish reported that the street light damaged by FDC had still not been replaced Cllr Mrs Bligh reported;

- (a) Plash Drove there had been requests locally for the speed limit for the built-up section to be lowered to 40mph from 60mph and asked the Parish Council to consider this when considering LHI's
- (b) A street light out at the Pigeons
- (c) FDC Leisure Centres are to be managed by an external company to save money

Cllr Booth reported;

- (a) FDC have agreed to pay for street lighting energy for a further twelve months
- (b) Speedwatch had been a success of 371 vehicles checked 21 were over the speed limit
- (c) Turf Fen Bridge site FDC had a 'tidy-up' planned
- (d) Guyhirn River Bank there had been a complaint that weeds had not been cut back near the steps opposite Chapelfield Road
- (e) 20Twenty Vision it had been raised that the villages should be included
- (f) GDPR CAPALC were providing assistance for a fee if there is a data breech
