Minutes of the Meeting of Wisbech St Mary Parish Council held on Monday 10 September 2018 at Wisbech St Mary Community Centre.

OPEN FORUMMrs S Pitcher requested additional street lighting in the vicinity of Selwyn Corner Guyhirn as it was dark at night time and adjacent to a busy road. Mr P McGregor supported the request as the footway was in poor condition and very easy to trip. There are only two lights between Selwyn Corner and Tholomas Drove. Ms Heyman also supported the request as vehicles travel at high speeds.

Cllr Bligh requested the Parish Council consider applying to CCC for a speed limit reduction to 40mph at Tholomas Drove through the Third-Party Funding option. Cllr Bligh described vehicles travelling at excessive speed past The Chequers into Plash Drove.

Cllr Knight believed that FDC Planning Committee had approved F/YR17/1217/F against the recommendations of the Parish Council. Given that the School and Health Care were at capacity it seemed strange that no Section 106 had been negotiated. Cllr Knight proposed that the Parish Council object to FDC. Cllr Booth said that he had submitted a complaint to FDC regarding the way the vote was managed which was probably why a formal Planning Notice of approval had not been issued. He added that no education or highways contributions had been secured despite the developer using a proposal by the Parish Council to reduce the speed limit to 30mph (not yet approved by CCC) as an argument to justify approval. It was proposed that a letter of protest be sent to the Head of Planning Services at FDC. **Agreed unanimously**
