The Parish Council also made the point that such an application should not be retrospective.
- 3. FDC Planning Services response to Parish Council representations regarding planning application F/YR17/1217/F. Following a summary of the situation by Cllr Wheeler it was agreed to advise the Head of Planning Services that the speed limit would not be 30mph as stated in the planning application and that it was doubtful that appropriate visibility splays could be achieved. It was also agreed to invite the Head of Planning Services to the Parish Council meeting in January.
- 4. Maxey Grounds Community Consultation 3 Proposed Dwellings, Gull Drove, Guyhirn. The Clerk had circulated the consultation and explained that a response was required by 4 December. Following discussion Councillors agreed; to support the principle of additional growth in Guyhirn beyond the 25 new dwellings limit applied by FDC, that this was not an appropriate location due to poor access poor visibility and therefore potentially dangerous, that this was not an appropriate scale of development at this site.

#### 6. CORRESPONDENCE RECEIVED

(a) CCC - Wisbech Area Transport Strategy – Fenland Town and Parish Council Discussion The Clerk reported details had been circulated. Councillors were encouraged to attend.

# 7. HIGHWAYS MATTERS

(a) Street Lighting

Following a site inspection by ClIrs Britain and Allen three poles have been identified as potentially suitable for new outreach brackets. ClIrs Britain and Wheeler and the Clerk have a meeting with Electrical Testing Ltd on 12 November, this is one of the items to be discussed.

It was agreed that plans of the lighting stock would be supplied to councillors.

Cllr Davies reported a light out on the bend near the village sign at Guyhirn.

- (b) High Road Wisbech St Mary Local Highway Improvement (LHI) 2018/19
- (i) Bellamy Bridge 2018/19 LHI The Clerk circulated the final design proposals from CCC which now show countdown markings on all four approaches. It was agreed to ask for improved 'bend ahead' signs if they could be accommodated within budget. The CCC design was agreed.
- (ii) High Road Wisbech St Mary 2018/19 LHI The Clerk had circulated a response received from CCC to councillors concerns regarding the draft design. Following discussion it was agreed that the proposals were the best that could be achieved. The CCC design was agreed.
- (iii) Station Road and High Road 2019/20 LHI The Clerk had circulated the CCC Feasibility Summary which included soft Traffic Calming on Station Road and potential to install a Mobile Vehicle Activated Sign (MVAS). Following discussion it was agreed that the proposals were the best that could be achieved. The CCC proposal was agreed. It was agreed that Cllrs Wheeler and Booth would attend the CCC assessment.

#### 8. FINANCE MATTERS

(a) To receive the Budgetary Control Report (BCR) for 2018/19 to date

The Clerk circulated the BCR and highlighted allotment received and bank reconciliation. Current balance was £115,423, a healthy position.
