Minutes of the Meeting of Wisbech St Mary Parish Council held on Monday 14 January 2019 at Wisbech St Mary Parish Community Centre.

OPEN FORUM Mrs S Pitcher asked for progress with the additional street lights requested at High Road Guyhirn, between Selwyn Corner and Tholomas Drove.

Mr Boyce reported that work had commenced to install a new service to the proposed street light at High Road, Wisbech St Mary.

1. APOLOGIES FOR ABSENCE Cllrs M Knight MBE, A Patrick, J Newland and Cllr King.

2. NICK HARDING, Head of Planning, Fenland District Council (FDC)

The Chairman welcomed Nick Harding and invited him to comment on various planning matters raised by Councillors.

- (a) Regarding feedback to parish councillors Nick reminded them that they could register with FDC to receive notifications. FDC do not have the resources to feedback on individual applications.
- (b) As regards growth limits there is currently no scope for change. However, in February FDC may decide to review the Local Plan. If so, the Parish Council can contribute what growth levels they feel are appropriate for the villages.
- (c) Section 106 Agreements: such agreements are inappropriate for developments of less than ten dwellings. FDC policy was that social housing would not be required for developments of less than ten dwellings. Nick explained that government policy places the emphasis on new housing delivery. FDC must carry out viability studies for the larger developments. Given the nature of developments in the Parish the potential for S106 agreements is small. S106 bids must be justified by mitigating the effects of the proposed development.
- (d) Regarding Gull Road: of fifteen checked, eight were approved, seven refused. Of those approved five were replacements, three satisfied the Infill Development test.
- (e) Regarding comments that Parish Council comments were ignored, Nick disagreed. 75% were consistent with Parish Council recommendations. Of three that had been refused one went to appeal which was turned down which supported the FDC decision.

Nick took comments and questions from councillors.

The Chairman thanked Nick for attending and explaining the Governments approach and that of FDC. He concluded that he would prefer the Parish Council comments to carry more weight.

3. TO SIGN AND APPROVE MINUTES OF MEETINGS dated 10th December 2018

The minutes were taken as read, agreed as a true record and signed by the Chairman.

4. MATTERS ARISING FROM PREVIOUS MINUTES (information only)

(a) CCC – Bikability cycle training in schools

The Clerk read a response from CCC: if CCC seek a contribution it is likely to be up to 25% i.e. £10 per pupil trained. CCC have contacted schools as well as Parish Councils. Training a trainer would involve a four-day course which costs hundreds of pounds and Continued Professional Development would also be required.

(b) Sayers Crescent – development not yet completed

The Clerk reported he had not yet received a reply from FDC.

8. HIGHWAYS MATTERS

(a) Street Lighting

The Clerk confirmed that a meeting was planned with other Parish Councils and Electrical Testing Ltd (ETL). A further meeting would follow between the Chairman, Vice-Chairman, Clerk and ETL. Cllr Booth reported that FDC employed ETL for Testing and Replacements, a separate firm was employed for day-to-day repairs. It was agreed that the strategy was to replace all old Parish units with new LED units and to replace the more modern columns/brackets with LED lanterns/lamps. In the interim a contractor qualified to carry out maintenance would be sought. Several instances where vegetation had overgrown lighting units were reported. It was agreed to compile a list and invite a quotation to cut back vegetation.

13. GUYHIRN PLAYING FIELD - Meeting/Changing Room

Cllr Allen explained that the estimated cost was £100k-£110k. Cllr Davies asked if the Parish Council would submit the planning application. It was proposed by Cllr Wheeler seconded by Cllr Scrimshaw that the Parish Council submit the planning application. Agreed unanimously. Cllr Wheeler explained that any bid for Parish Council funding must be supported by detailed costings. Ownership and management responsibilities also needed to be clear. There was no commitment to the Parish Council owning the building.

14. REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr Booth reported:

- (a) The latest Speedwatch survey of 76 vehicles 5% were above the threshold. Further training and volunteer sessions were planned.
- (b) FDC would hold an extraordinary meeting Thursday to discuss CCTV
- (c) Planning training was available at FDC Thursday night.
- (d) Most fees and charges would be held the same or with an inflationary increase, burial charges would be increased in line with neighbouring authority charges.
