OPEN FORUM – Parishioners are invited to address the Council.

- (a) Diane Cutler (DC) provided an update on Murrow Street Pride. DC reported that additional volunteers were coming forward and MSP was promoted on social media.
- (b) DC reported there had been an excellent response to appeals for volunteers for Guyhirn Speedwatch, twelve were awaiting training. It was clear from survey results that more measures are required if vehicle speeds were to be reduced from 40 to 30mph.

7. HIGHWAYS MATTERS

(a) Street Lighting

The Clerk reported that Electrical Testing proposed to start work on the arterial routes 16 September 2019. He was asked to clarify estimated costs for the upgrade of the remaining street lights. Two street lights were reported out – The Chairman will report these to Wisbech Electrical.

(b) Highways

Cllr Allen stressed the need for High Road Guyhirn to be resurfaced.

Cllr Knight reported weed growth throughout High Road Wisbech St Mary.

Cllr Booth reported that only one Local Highway Improvement bid was allowed from the Parish despite community groups being invited to bid. This effectively meant that a community bid had no chance of being considered. This seemed unfair as it was a large Parish with several villages and three County Councillors and many issues to resolve. The Clerk was asked to contact CCC to voice concerns and request a review.

Cllr Britain drew attention to a large depression in the highway verge at Tholomas Drove. Cllr Britain will report it via the CCC reporting system.

Cllr King offered to investigate the issues raised.

The Clerk reported that locations for the Mobile Vehicle Activated Sign at Guyhirn were being identified. Before the sign can be deployed Insurance is require for volunteers, the increase in premium will be reported to a future meeting. **Noted**

8. FINANCE MATTERS

(a) To receive the budgetary control report for 2019/20 to date.

The Clerk circulated the report, drew attention to planter sponsorship received and to the Bank Reconciliation which balanced at £118,132. **Noted**

The Chairman explained that the changes were due to the Clerk no longer paying National Insurance.

(d) Clerk postage and office consumables £108.70 LG Act 1972 S112 **Agreed** The Clerk reported this was for a new printer with five year warranty.

(e) FDC – Litter bins £1111.46 LG Act 1983 SS5-6 **Agreed** (f) Thorney Toll Village Hall - hire August £40.00 LG Act 1972 S134 **Agreed**

(g) Bowles Tree & Garden Services – maint'. £2310.00 LGMisc Prov Act 1976, S196 **Agreed** The Clerk reported that the sum was £100 less that the invoiced amount to pay for planter sponsorship.

(h) SWARCO Traffic Ltd – Mobile speed sign £3688.57 Highways Act 1980 **Agreed** The Clerk reported the amount differed from that shown on the Agenda due to a typing error. The Clerk had amended the amount invoiced to reflect work claimed for which had not been provided, with the agreement of SWARCO.

(i) Wisbech St Mary Sports and Community Centre -£5,000.00 towards sports field upkeep, LG Misc Prov 1976 S19. Following discussion it was proposed by Cllr Knight seconded by Cllr Humphrey to grant £5000. **Agreed unanimously.**

9. PARISH PROPERTY

(a) Maintenance

The pond at Wisbech St Mary requires improvement, councillors Knight and Humphrey agreed to meet with S Bowles to discuss what could be achieved. **Agreed**

Cllr Britain reported that Clarion Housing had requested house numbers for the trees that required pruning. The Clerk was asked to arrange for the weeds to be removed at the Thorney Toll Bus Shelter.

- (b) Defibrillators Cllr Britain reported the replacement batteries and pads had been fitted. Noted Cllr Britain asked if a defibrillator could be provided at Tholomas Drove, to be discussed at the next meeting.
- (c) Planters it was noted that some minor attention was required to a few of the planters.

10. MURROW BUS SHELTERS

Cllr Fryett suggested two shelters but sites were difficult to identify. Councillors Knight, Fryett and Scrimshaw would meet to identify potential sites taking into account passenger pick up points.

11. GREEN DOG WALKERS SCHEME

Following discussion it was agreed to support the scheme in principle subject to costs. It was suggested that Wisbech St Mary Street Pride Group could consider this and apply for a grant.

12. HIGHWAY VERGES - VILLAGE GRASS CUTTING

Following discussion it was proposed to invite five quotations for three and four cuts per year commencing 2020. **Agreed**

13. GUYHIRN PLAYING FIELD - Meeting/Changing Room

Cllr Allen reported that Cllr Davies had received 40-50 replies and more information would be provided

at the next meeting. It was agreed to defer the item to the next meeting.

14. REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

CCC Cllr King reported:

- (a) At the Highways Infrastructure Meeting tomorrow it was proposed that non-intervention level potholes would be repaired during the same visit of the Dragon-patcher as intervention level pothole repairs. Also, there was a possibility of capital funding for community facilities to be put into a 'pot' to be bid for.
- (b) Trees at Tholomas Drove pruning/removal of dangerous growth had been arranged, the landowners will be invoiced.

FDC Councillor Booth reported:

- (a) Parnel Road had been submitted for resurfacing.
- (b) Report regarding Street Lighting energy may go to FDC Cabinet.
- (c) FDC are selling surplus assets including plots of land.
- (d) Council Tax Support Scheme consultations likely at the end of the year.
