Recommend Refusal – Highway considerations (increased congestion and potential safety issues with right turning traffic) and object to the change of use.

Councillors also object to a planning application received after the work has been done.

6. CORRESPONDENCE RECEIVED

- (a) FDC Conduct Procedure The amended Procedure now applies
- (b) CCC Operation London Bridge CCC leads on the protocol through the Lord-Lieutenant's office. Gillian Beasley Chief Executive will be providing more information.
- (c) UK Power Networks (UKPN) Wayleave Agreement Mouth Lane. The Clerk explained that UKPN were acting for CCC/BT superfast broadband and were requesting a wayleave agreement to install an underground electric supply from the pole at the rear of the allotment to the road at the front. Councillors considered an underground supply unwise, suggested overhead as an alternative and £500 as a reasonable one-off grant to the Council.

7. HIGHWAYS MATTERS

(a) Street Lighting

The Clerk provided an update on the current phase – Electrical Testing Ltd were committed to completing work including two new units at Murrow Bank.

Phase 2 – The Clerk referred to the options considered in April: £12,500 for lantern only conversions (51 units), £15,800 for column replacements and re-plumbs (15 units), £13,300 pole bracket units (20 units). All lanterns would be LED. Total cost £41,600.

Following discussion and vote by 8 in favour, 1 against it was decided to proceed. Agreed

(b) Highways

(i) Community Speed Watch – signs Cllr Booth declared an interest The Clerk read an email requesting support for the installation of signs to raise awareness of the need to adhere to speed limits. Diane Cutler explained that the Parish Council needed to make an application to CCC who would provide an assessment, estimate including staff costs and timescale. Murrow was suggested as the first village to be considered. It was agreed to support the proposal and make the application.

 It was proposed by Cllr Humphrey seconded by Cllr Knight that £2500 be approved. **Agreed unanimously**
- (I) Councillors agreed to consider a grant to Wisbech St Mary Street Pride Group for the Green Dog Walkers Scheme deferred from the last meeting. Cllr Bligh explained the scheme and what was proposed. It was proposed by Cllr Humphrey seconded by Cllr Knight to grant £265. **Agreed**

9. PARISH PROPERTY

(a) Maintenance

The Clerk reported quotes had been invited for highway grass cutting in the villages with a return date 4 December 2019.

Cllr Davies reported that lettering at the Guyhirn War Memorial was in need of attention. It was agreed a properly qualified and experienced supplier was required.

Cllr Humphrey reported that adjacent owners had agreed to help with maintenance of Wisbech St Mary Pond.

(c) Defibrillators

Cllr Knight reported that the unit at Wisbech St Mary had recently been required.

Cllr Booth reported that Cambridgeshire Community Foundation had agreed to review the bid for a unit at Tholomas Drove.

(d) Planters

Cllr Wheeler reported that the Planter at Tholomas Drove damaged by a vehicle collision had been made safe and repair would follow. It may be possible to claim through insurance.

10. MURROW BUS SHELTERS

Cllr Knight explained that to progress the proposed Bus Shelters at Murrow an assessment was required by CCC for which £500 was required in advance. Following discussion it was proposed by Cllr Scrimshaw seconded by Cllr Allen to agree payment to avoid undue delay. **Agreed unanimously**

The Clerk was asked to clarify with CAPALC whether CCC had powers to charge for the assessment.

11. STANDING ORDERS AND FINANCIAL REGULATIONS

It was proposed by Cllr Davies seconded by Cllr Fish to formally adopt the Standing Orders and Financial Regulations circulated at the last meeting. **Agreed unanimously**

12. GUYHIRN PLAYING FIELD - Meeting/Changing Room

The Clerk reported that no formal grant application had been received. Cllr Davies said a quote was awaited. It was agreed to add the item to the next agenda if a grant application was received.

13. GUYHIRN PLAYING FIELD ACCESS

Cllr Davies reported that the owner of land to the rear of the playing field had been contacted and he would meet with them shortly to discuss damage to the access by heavy lorries.

14. MURROW 'POND'

It was agreed to defer this item to the next agenda.

15. UNADOPTED ROADS - TOP DRESSING

Cllr Mrs French explained that CCC were offering surplus road planings free of charge to help with maintenance of unadopted roads. Applicants will need to spread them themselves. It was agreed that councillors would supply names of roads to the Clerk to pass on to Cllr French.

16. REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

FDC Councillor Bligh gave an update including:

- (a) 1000 leaflets had been printed to encourage people to get involved with maintaining the planters.
- (b) £500 grant had been secured from FDC for wheelie bin stickers to raise the profile of speed limits.
- (c) Seats were required in two bus shelters, one near Chapel Avenue.

FDC Councillor Booth reported:

- (a) At the 4 November Council meeting a new remuneration scheme for District Councillors had been agreed.
- (b) A new rate relief policy was proposed to encourage medium sized enterprises
- (c) At Overview and Scrutiny Committee it was announced Kingdom Street Scene enforcement was coming to an end. However, FDC Street Scene officers will continue enforcement.

CCC and FDC Cllr Mrs French reported:

- (a) As Time Banking Champion there were opportunities to apply for support, £20k over 2 years.
- (b) Regarding Street Lighting Energy a draft report was expected to go to Cabinet 9 January 2020.
- (c) FDC Cabinet in-house enforcement was being considered, including decriminalised parking (not pay parking).

CCC Cllr King's report was given by the Clerk in his absence:

- (a) Biocow I arranged a meeting to discuss the planning conditions for their most recent application. We agreed that completing the resurfacing of Cants Drove from Biocow to Murrow Bank (and possibly the passing places) would be a condition so these improvements should be completed in the near future.
- (b) Bus Shelter Despite my best efforts, I am very sorry to say that I have been unable to get the £500 fee waived. All I can promise is that I will try to get my fellow councillors to reconsider this charge as it relates to Parish Councils in the future.
- (c) Tholomas Drove Trees As soon as I have more information, I will forward it to the Clerk.
- (d) Bellamys Bridge The bridge repairs should be done shortly.
- (e) Verge at Plash Drove and Salt Pit Ln I'm very sorry this has not been reinstated and I've chased it up
- (f) Missing bus stop sign on Black Drove opposite Folley's Drove I've also chased this up
