7. HIGHWAYS MATTERS

(a) Street Lighting

The Chairman reported a meeting with Electrical Testing Ltd (ETL) to visit all those lights not yet completed from phase 1 - some require traffic management. A further meeting has been arranged for 28 January to visit all those to be included in the phase 2, this will include some that were missed during the original survey. ETL have acknowledged that improvements need to be made and have confirmed their commitment to satisfactorily completing the work. Materials will be ordered following the meetings ready for installation May/June 2020. Two new units will be installed at Murrow. ETL cannot install two new units at Guyhirn due to high voltage overhead cables. The Clerk is exploring whether UK Power Networks can install them, approval is firstly required from CCC for the Parish to install new apparatus in the highway.

- (b) Highways
- (i) Cllrs Wheeler and Booth will attend the Local Highway Improvement assessment on 22 January.
- (ii) Cllr Booth requested consideration of speed management at Murrow Bank and Sand Bank through the privately funded highway improvement process. It was agreed to go ahead in principle to enable the possibilities to be explored and to add to the agenda for the next meeting.

The Clerk explained the predicted spend for 2020/21 was higher than normal due to street lighting replacements and energy. If the precept remained the same it would result in a low end of year figure. It was proposed to increase the precept by £25,000 to achieve an end year figure more in line with the precept, generally considered a wise precaution. The resulting increase payable would be £20 per year, 40p per week. Cllr Davies highlighted that Fenland District Council had previously paid energy costs but were now forcing the Parishes to pay for energy in addition to replacing street lights, so there is no alternative to increasing the precept. Proposed by Cllr Britain, seconded by Cllr Fish councillors reluctantly agreed unanimously to increase the Precept.
