Minutes of the Meeting of Wisbech St Mary Parish Council held on Monday June 8th, 2020 via 'Zoom'.

15. APOLOGIES FOR ABSENCE Cllr B Britain due to emergency business commitments, Cllr S.Mann, Cllr J Fish.

The Chairman invited CCC Leader Cllr Steve Count to give his report so he could leave to attend other business.

11.1 REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr Count reported:

- (a) CCC had Public Health and Resilience Forum responsibilities. They provided regular information for the public and updates. He warned that there is a natural tendency to move attention to the latest issues and stressed the importance of continuing the basic precautions such as washing hands frequently and social distancing.
- (b) Cllr Count drew attention to the valuable work FDC had been doing through advice, action, help and signposting.
- (c) He explained that the current R value for the Eastern Region was 0.94, with Fenland District in mid-pack of the lower pack of the Eastern Region.
- (d) CCC has a responsibility for schools including private academy trusts. This has included reviewing and fine-tuning risk assessments for 150 schools, with Unions involved. It is the schools choice to open or not. Currently 75% of schools are open with 25% attendance.
- (e) Test Track and Trace is a national initiative with no CCC involvement. If there are symptoms request a test, if positive all in the household must self-isolate.
 - (f) CCC monitors outbreaks and investigates.

Cllr Count closed by stressing that the emphasis is on prevention, maintaining the flow of information and advice. Coronavirus is past its peak in Fenland District but it is important to continue following recommendations in order to keep R below 1.

The Chairman thanked Cllr Count who then left the meeting.

The Clerk had circulated copies to all. Following a review of the statements it was proposed by Cllr Scrimshaw seconded by Clir Booth that the Annual Governance Statement be approved. The resolution to accept the Annual Governance Statement was Approved unanimously. The Clerk and Chairman were authorised to sign the Statement.

8. PARISH PROPERTY

(a) Maintenance

Cllr Bligh reported that some planters required attention. Maintenance would resume when coronavirus restrictions permitted.

9. GUYHIRN FOOTBALL CLUB

Cllr Davies referred to the enquiry received from the Manager Guyhirn Football Club circulated to all. The Playing Field Committee had discussed the request but felt that the infrastructure could not cope with a significant increase in the number of games that would be played. The increase in maintenance required and noise were also factors to consider. Following discussion, it was agreed to defer the item to the next meeting.

10. RECRUITMENT

The Chairman explained that it had not been possible to hold interviews due to social distancing. He thanked the Clerk for continuing in the role. He proposed to explore with candidates the possibility of holding interviews by Zoom, alternatively to hold interviews by middle of July if social distancing restrictions were relaxed. The Clerk will contact the candidates. **Agreed.**

11.2 REPORTS FROM DISTRICT AND COUNTY COUNCILLORS

CCC Cllr King:

- (a) Congratulated Cllr Booth in his efforts delivering prescriptions.
- (b) CCC have commenced clearing the backlog of larger schemes, a high number of minor repairs have been completed during the lockdown.
- (c) In response to Cllr Davies request he agreed to chase the replacement of the missing bus stop sign.

FDC Cllr Bligh reported:

- (a) StreetPride ceased due to the coronavirus restrictions.
- (b) Charities have received financial support from FDC.
- (c) Full Council meetings are due to be held by FDC 17 June and in August.

FDC Councillor Booth reported:

- (a) FDC Planning Committee is meeting via Zoom.
- (b) Freedom Leisure has received loans from FDC.
- (c) Anglian Water have been invited to FDC to explain why low pressure issues keep occurring particularly as large developments are planned in and around Wisbech.
- (d) Helping Hands approx. 20 people have volunteered to work with pharmacies to help 200 people.
- (e) Help with shopping is available through FACT.

The Chairman thanked Cllr Booth for his efforts.

Cllr Booth reported that some reports of vehicles speeding had been reported to Police.
