Minutes of the Meeting of Wisbech St Mary Parish Council held on Monday August 10th, 2020 via 'Zoom'.

OPEN FORUM – Parishioners are invited to address the Council. **Nil**

1. APOLOGIES FOR ABSENCE – resignation of Cllr John Fish. The Chairman reported the Notice of Vacancy had been posted. If an election were necessary it would not be before 6 May 2021, otherwise it would be filled by co-option. The Chairman paid tribute to John Fish for his work over many years, he had always worked hard to benefit Thorney Toll. All councillors joined to send their thanks to John and their best wishes for good health.

Apologies were received from Cllrs S Mann – work commitments, D Scrimshaw – work commitments and CCC Cllr S King - illness.

10. RECRUITMENT

The Chairman reported that Sarah Bligh had been offered the post of Clerk and Responsible officer and had accepted. He added that support would be available from a past parish clerk including guidance with the Certificate in Local Council Administration Qualification.

It was proposed by Cllr Britain seconded by Cllr Allen that the appointment be confirmed. **Agreed unanimously. Sarah Bligh then joined the meeting.**

8. FINANCE MATTERS

(I) Guyhirn Football Club - £30,000 grant towards changing facilities and community room.

The Chairman summarised the situation and thanked Guyhirn Football Club (GFC) for their submission. He felt there was support for the proposal in principle but there were serious reservations. During detailed discussions it was clear that more detail was required to make the plan robust and viable; a strong committee with a constitution in place to oversee the project and manage finances both in the short and long term, clarification that all possible costs had been included, a contingency fund, the funding plan to show how potential losses would be mitigated. Potential funding opportunities had not been explored.

In response Mr A Gardner and Mr E Vanhinsberg (GFC) provided further information.

Cllr Davies reported a £5k grant from the Playing Field Association.

The conclusion was that there was clear need for the facility in the village and support for the proposal but the Council must be satisfied that the investment is a sound one. It could not sanction a £30k grant based on the bid submitted.

It was suggested that Cllr Davies and/or Cllr Allen provided guidance to GFC. GFC then submit a revised bid. GFC explained the need to progress rather than waiting for the next Parish Council meeting and offered to develop the plan immediately.

It was proposed by Cllr Fryett seconded by Cllr Booth that an extraordinary meeting be convened, if necessary, to consider a revised bid. **Agreed unanimously**

Recommend Refusal – over development, flood risk and potentially dangerous access.

(b) F/YR20/0591/F Change of use of land and the erection of stables for equine and agricultural use. Land North East Of Corner Farm Willock Lane Wisbech St Mary.

Applicant Mr Goat. Agent Alexandra Design. Recommend Approval

(c) F/YR20/0598/O Erect up to 5 x dwellings involving the formation of a new access (outline application with matters committed in respect of access). Land North Of The Barn High Road Bunkers Hill. Applicant Mr A White. Mr D Broker.

Recommend Approval subject to speed reduction features to be installed in High Road through the Infrastructure Development Policy.

(f) Street Naming. The Clerk reported a proposal received form FDC Street Naming and Numbering to name a spur off Spencer Drove. Councillors considered that Crews Close had no local connection and preferred the development to be known as Spencer Drove.

The Clerk reported that SWARCO, the MVAS supplier, provided maintenance contracts, Silver at £123 and Gold at £287. Following consultation with the operator it was recommended that Silver cover would be adequate. **Agreed**

The Clerk reported a quotation had been invited for the replacement of the glass panels. Cllr Fryett suggested P Tibbs as an alternative supplier. The Clerk to obtain a quotation.
